6. **PROOF OF DATE OF BIRTH** : (As per matriculation certificate)
7. **CHARACTER CERTIFICATE**: Conduct and Character Certificate from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer, not more than six months old (in original).
8. **RESERVATION CERTIFICATE**:
  - a. The reservation certificate would be issued from the respective state/region in which the reservation is claimed e.g. in case any candidate claims for the seat reserved for DSC/DST category then he /she has to bring SC/St certificate issued by Govt. of NCT of Delhi and also should have passed his/qualifying exam from Delhi.
  - b. SC/ST Physically Handicapped /Defence Category/ Kashmiri Migrants whichever applicable, on the basis of which reservation is claimed (Original and One Photocopy).
  - c. The provision for reservation in OBC category is not applicable for Post graduation/ Master level Programmes. However, the OBC category candidates may claim seat in General category in the order of their rank as per merit, as per their respective regions.
  - d. For Clarification on region i.e. Delhi or Outside Delhi and reservation policy, Candidates may please refer to the Chapter V: Seat allocation, Chapter VI: Reservation Policy respectively of Part A, Admission Brochure 2019-20.
