In pursuance of the notice/letters/Gazette notification under above reference, Guru Gobind Singh Indraprastha University shall carry out an Extended round of Offline counseling to fill up the vacant seats in Post Graduate Medical Courses (MD/MS/Diploma) in affiliated medical colleges of GGSIP University.

Schedule

6. **Time and Date of Registration (Offline) in the prescribed format (attached) at the Admissions Branch of GGSIP University** – 11:00 a.m. onwards on 11.05.2019 to 05:30 p.m. on 11.05.2019
7. **Time and Date of Verification of documents** – 10:30 a.m. onwards on 13.05.2019 till 01:30 p.m. All such candidates who have not registered earlier has to deposit Rs. 1000/- as 'Registration Fee'.
8. **Time and Date of Counselling/Allotment of Seats** – 02:30 p.m. onwards on 13.05.2019

9. **Venue for Verification of documents and Allotment of Seats**– “C” Block, Seminar Hall, Guru Gobind Singh Indraprastha University, Sector 16-C, Dwarka, New Delhi - 110078
10. **Vacant seats**: Final vacancy position shall be made available before the allotment of seat.
11. **Eligible for Extended Counselling**:
- Candidates who have qualified their MBBS degree from GGSIPU and have registered on University portal but could not verify their documents on 04.04.2019 due to non-eligible on the basis of pre-revised cut off score.
 - Candidates who have qualified their MBBS degree from GGSIPU and did not register on University portal as their score at that time being lower than the cut off defined by MCI & NBE.
 - Eligible candidates who have qualified their MBBS degree from GGSIPU and registered themselves on University portal, however, did not report for verification of documents scheduled on 04.04.2019 due to any reason.
 - Fresh applicants/MBBS graduates of GGSIPU, who did not due to any reason register themselves on University portal and now wish to apply for admission in PGMC (MD/MS/Diploma) under State/Institutional Quota.
 - The candidates who have qualified their MBBS degree from GGSIPU and have become eligible subsequent to the lowering of the percentile/score and are now eligible for PGMC Counseling under State/Institutional Quota.
 - The candidates who had participated in ‘Registration for Counselling and Verification of Documents but have not been allotted a seat / not opted a seat /or absent at the time of seat allotment in Round I and Round II and Mop-Up round.
 - Allotted in Round I but subsequently had withdrawn within the stipulated date not allotted/admitted in further round.
 - Allotted or upgraded or changed college / preference in Round II but did not join his/her respective seat within the stipulated date.
 - Any other condition for eligibility/non-eligibility shall be applicable as per rules/guidelines.

12. **Fees to be paid at the time of counseling/allotment of seat:**

Non SC/ST/OBC	Rs. 25,000/-	Rs. 26,000/-

A candidate, who is allotted a seat, will be required to pay the above detailed fee on the spot, at the time of counseling. The fee will have to be paid in the form of Demand Draft in favor of “Registrar, Guru Gobind Singh Indraprastha University” payable at Delhi. Balance fee, if any shall be paid, directly in the allotted college after admission.


13. **Joining at the allotted college: It is mandatory for candidates who opt a seat in the counseling to report in the allotted medical college on 14.05.2019 or as per the schedule vide gazette notification dated 20.02.2018.**

14. For, 'Documents required at the time of Counselling/Allotment of Seat'

(1) NEET Admit Card 2019 (2) NEET Score Card 2019/Revised Score Card (3) Admission Verification Form, as available in Part B of Admission Brochure 2019-20 (to be filled up by the candidate) (4) Preference Sheet as available in Part B of Admission Brochure 2019-20 (to be filled up by the candidate) (5) Surety Bond, as specimen available in Part B of Admission Brochure 2019-20 (to be submitted in the allotted college) (6) 10th Class Certificate as proof of date of birth (7) MBBS Degree (8) Detailed marksheets of qualifying examinations: I, II and Final Professional examination of MBBS (9) The compulsory rotatory internship certificate (10) Registration Certificate from Delhi Medical Council / State Medical Council (11) Reserved Category Certificate, as applicable. The surety bond is between the institution and the admitted student, there is no role of the University in the surety bond (15) PAN Card/Driving Licence/Voter Card/ Passport/Aadhar Card (16) Passport size photographs – 4 nos. (required on the date of counselling/allotment of seats) candidates are required to please refer to Clause A. (ix) of the first counselling schedule held on 04.04.2019 and 05.04.2019.

12. The Extended Counselling shall start from the Roster Point (next from the roster point at which the last seat was allotted in Mop –up round). Seats will be allotted to the eligible candidates in their respective categories on the specific roster points and in the order of merit.
