- (i) The contents of the thesis should be organized in the following manner:
  - (a) Certificate of Originality signed by the research scholar and supervisor in the prescribed format (see below)
  - (b) Supervisor's Certificate for Exclusion of Self Published Work in the prescribed format (see below)
  - (c) Consent Form for Depository with Shodhganga or INFLIBNET or any other database designated for this purpose by the UGC in the prescribed format (see below)
  - (d) Acknowledgement
  - (e) Abstract
  - (f) Table of contents
  - (g) Abbreviations
  - (h) List of figures/tables
  - (i) Body of the thesis
  - (j) References
  - (k) Appendices
  - (l) List of publications and Conferences attended
  - (m) Reprints of paper(s) published from the Ph.D. work
  - (n) One page bio-data of the Ph.D research scholar (optional)
- (ii) Thesis should be type-written on good quality A-4 size paper with line-spacing of 1.5 and margins of 1.5-2 inches on the left side for binding and 1 inch for the remaining sides. The thesis may be written on both sides of the A-4 size paper.
- (iii) Suitable reproduction of Indian-ink diagrams should be used. Photographs should be reproduced on photo/good quality paper.
- (iv) References should be given in a style in the text and in bibliography consistent with a standard journal in the field. Ideally, research scholars from each School should follow the same format.

- (v) The outer cover and the inner cover page of the thesis should follow the format given below.
- (vi) Three copies of the thesis in soft-binding along with one copy on electronic media in MS word/PDF format must be submitted to the COE for evaluation.
- (vii) After the conduct of open viva-voce examination, two copies of the final thesis in maroon colour hard cover binding must be submitted to COE, along with the no dues certificate in the prescribed format.
- (viii) The following should be printed on the spine of the thesis:
  - (a) Year of award at the top
  - (b) The research scholar's name in the middle (last name followed by initials)
  - (c) Ph.D. at the bottom
