OFFICE MEMORANDUM

It has been observed that there is no uniformity in processing of proposals by the Department(s) concerned relating to exercise of powers and functions of the Chancellor under the respective acts of the Universities created by legislations passed by the Legislative Assembly of Delhi.

The provisions of Acts and Statutes of Universities of NCT of Delhi and rulings of Hon'ble Apex Court and Hon'ble High Courts make clear that the functions of Chancellor are distinct and separate from that of the Lieutenant Governor.

The Acts/ Statutes of all the Universities provide that the Vice-Chancellor shall be appointed by the Chancellor from a panel of 3-5 names selected by a Committee comprising of 3-6 members.

The crux of judgment of Hon'ble High Court of Punjab and Haryana in the matter of Hardwari Lal vs. GD Tapase and Ors. (AIR 1982 PH 439), Hon'ble High Court of Andhra Pradesh in N. Kiran Babu vs. Govt. of Andhra Pradesh and Ors. (AIR 1986 AP 275) and Hon'ble Supreme Court judgment in the matter of State of West Bengal vs. Anindya Sundar Das and Ors. [(2022) SCC online SC 1382], is that the power of appointment rests with the Chancellor and not with the State Government. The State Government is an authority quite distinct of the Chancellor and the State Government cannot advise the Chancellor to act in a particular manner.

Abovesaid acts, statutes and judicial decisions make it clear that the powers and functions of the Chancellor are not in the capacity of Lieutenant Governor, and therefore no question arises for processing such matters as per the Transaction of Business of the Government of NCT of Delhi Rules, 1993.

Accordingly, the Chancellor has decided that, henceforth, the proposals relating to exercise of powers and functions of the 'Chancellor' under the respective Acts of the Universities created by Legislations passed by Legislative Assembly of Delhi shall be processed for his decision strictly in accordance with the Acts / Statutes of such Universities directly through the Chief Secretary.
