CIRCULAR

The resolution/ suggestion made/ given vide "Agenda Item No. PB 14.07 i.e. "Suggestions for new collaborations/ MoUs with National/ International Universities/ Organisations" during the 14th meeting of 'Planning Board of GGSIP University' held on 12.11.2022 is mentioned as under:

*"The Hon'ble Vice Chancellor apprised the Board that the University has increased MoUs with national/ international institutions and the industry. He further mentioned that **all the MoUs signed by the University must be taken care of and a Nodal officer may be appointed for providing the action taken report on the MoUs signed by the University.**"*

In pursuance to above, the Hon'ble Vice Chancellor, GGSIPU has nominated "**The Statistical and Planning Branch**" of the University as a Nodal branch for keeping the records/ ATRs of all the MOUs signed by the University and take further appropriate action, as deemed fit.

Further, the Hon'ble Vice Chancellor approved the following:

- a) The Memorandum of Understanding (MOUs) with other institutions/ industry are signed by all the Schools of Studies/ Centres of the University. **The Schools/ Centres should nominate one person at School/ Centre Level who will be responsible for keeping the records of the MOUs signed by their respective Schools of Studies/ Centres, conduct the activities entered with MOUs, assess outcome of such MOUs and provide Action Taken Report to the Dean(s)/ Directors(s) of their respective Schools of Studies/ Centres.**
- b) The Dean(s)/ Director(s) of concerned School of Studies/ Centres should forward the details of MOUs/ Action Taken Report on their MOUs to the **Statistical and Planning Branch** of the University.

Accordingly, all the Dean(s) / Director(s) are requested to forward the details as mentioned at point (a) & (b) above, to "**The Statistical and Planning Branch**" of the University within 15 days from the date of issue of this Circular.
