Note for CET qualified candidates:

The seat(s) shall be offered to the qualified candidate(s) in order of merit with respect to his/her Region (Delhi/Outside Delhi) and along with the applicable Reservation (GEN/SC/ST/PWD/DEF) provided he/she reports for counselling/ allotment of seat at the venue on the specified date & time.

FEE: The candidates will mandatorily have to pay the Part Academic Fee of Rs. 96000/- along with Counselling Participation Fee of Rs. 1000/- (non-refundable) in the form of Demand Draft in favour of Registrar, GGSIPU, payable at New Delhi at the time of allotment of seat at the counselling venue. The balance fee, if any, is to be paid by the candidates at their allotted college/institute.

ELIGIBILITY: Pass in D. Pharma course from an institution approved by the PCI u/s/ 12 of Pharmacy Act, 1948.

VACANT SEAT STATUS: will be notified at the counselling venue.

RESERVATION: Refer Admission Brochure 2024-25.


All the candidates allotted in the 1st round of counselling shall report in the allotted college latest by 23rd October, 2024.


Important Note: Any other terms and conditions as defined by the Statutory body/Competent Authority, shall be applicable for counselling/ admission process.
