# Notice – Introduction of New Course Nurse Practitioner Critical Care Programme (CET Code 116)

## Regarding inviting Application Forms for admission to Nurse Practitioner Critical Care Programme (CET Code 116) during the Academic Session 2024-25

It is for information of all the stakeholders that Guru Gobind Singh Indraprastha University has introduced a new programme i.e. Nurse Practitioner Critical Care (CET Code 116) at Max Institute of Nursing Education & Training, Max Super Speciality Hospital, A Unit of Devki Devi Foundation, 2 Press Enclave Road Saket New Delhi 110017 during the Academic Session 2024-25. Details are as below:-

### **ELIGIBILITY CRITERIA:**

- i. The candidate should be a Registered Nurse and Registered Midwife with any State Nursing Registration Council.
- ii. The Minimum education requirements shall be the passing of: -
  - B.Sc. Nursing / B.Sc. (Hons.) Nursing / Post Basic B.Sc. Nursing/ M.Sc. Nursing with minimum of 55% aggregate marks from an institution which is recognized by Indian Nursing Council.
- iii. Minimum one year of work experience prior to or after Post B. Sc Nursing (preferably Critical care units).
- iv. Minimum one year of work experience after basic B.Sc. Nursing (preferably Critical Care units) is desirable.

### ADMISSION CRITERIA

i. The merit for admission will be on the basis of interview (25% weightage for interview & 75% for marks obtained in the last qualifying examination).

All other terms and conditions shall be as mentioned in the Admission Brochure 2024-25.

All those candidates who fulfil the above mentioned eligibility criteria for admission in above programme and are desirous to seek admission in the same, are

required to apply in a physical mode, in the prescribed format (Annexure A) and submit their request during working days/hours at the Facilitation Centre of Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi w.e.f. 22.04.2024 till 15.05.2024 along with the copies of relevant certificates (self attested) along with a non-refundable Registration fee of Rs. 1500/- through Demand Draft drawn in favour of the Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi.


