

In light of above, it is, therefore , requested to go through the details of these awards and take further necessary action at your end on the afore said online web-portal ,



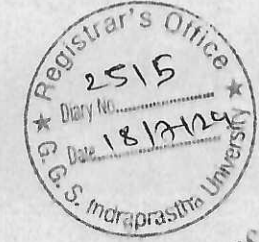
