



4. The guidelines for admission to the above referred supernumerary seat for "Single Girl Child" in each UG/PG Programme offered at University Schools of Studies from Academic Session 2024-25 onwards, will be as follows:

**(i) Applicability**

1. "Single Girl Child"
2. In case of twin (both girls) as first children, both girls shall be eligible.
3. In case of twin (one boy and one girl) as first children, only the girl child shall be eligible.

**(ii) Eligibility Criteria for Admission :**

The candidate must fulfill the Eligibility Criteria prescribed in the respective Admission Brochure for UG/ PG Programmes offered at various University Schools of Studies for the Academic Session 2024-25.

**(iii) Number of Supernumerary Seat :**

One seat in each UG/ PG Programme offered at University Schools of Studies.

**Note:**

1. This one seat is supernumerary in nature. In case, the applicable Regulatory Body has imposed any restriction towards creation of supernumerary seat, one seat shall be earmarked for "Single Girl Child" from within the sanctioned seat intake.
2. This one seat is filled up on All India Basis i.e. without any Regional allocation (Delhi/ Outside Delhi) as well as any other reservation viz SC/ST/Def/PwD/OBC/EWS etc. This seat shall be allotted purely on the basis of merit of applicable National Level Test/ Common Entrance Test/ Merit of Qualifying Examination, as the case may be.
3. The candidates will be required to submit separate application form alongwith prescribed fee for each programme
