## <u>Circular</u> Important Instructions- Anugoonj 2025

24<sup>th</sup> Annual Cultural Festival Anugoonj 2025 is scheduled to be held from 24<sup>th</sup> February, 2025 to 26<sup>th</sup> February, 2025. The details of the events and eligibility criteria for participation has already been notified by Director of Student's Welfare separately.

In order to ensure due safety, all faculty, students and staff are requested to follow the below mentioned guidelines:

- 1. Entry is permitted only for the students of University School of Studies & its Affiliated Institutions on the basis of valid I card only.
- 2. Participants are requested to ensure that they have invitation/documents issued by DSW, GGSIPU.
- 3. Entry of Student vehicles, even with valid stickers is not permitted during Anugoonj-2025. Students are advised to use local transport for their own convenience and may use parking facility available at Sector-14 Metro Station.
- 4. Vehicles of Hostelers shall not ply inside the Campus. Such Vehicles will be parked inside their respective Hostel premises during the Anugoonj- 2025. Any violation in this regard will be viewed seriously & may attract disciplinary action.
- 5. All Residents/Hostlers are informed that entry of Delivery Agents of E-commerce Apps (Amazon, Flipkart, Zomato, Swiggy etc.) shall be prohibited from 11:00 AM to 8:00 PM. It is requested that they may make alternate arrangements well in advance for their own convenience.
- 6. All residents are further informed that entry & exit from Gate No. 02 shall be restricted during peak hours of Anugoonj i.e from 12:00 Noon to 8:00 PM
- 7. Girls students are advised not to carry Hand Bags as it might hamper & delay their clearance for entry in the campus. Further, perfumes, sprays and other such items which contain inflammable substances are not allowed in the University premises.
- 8. Any student found in possession of any prohibited substances such as Drugs, Alcohol, Cigarettes etc. may be liable for strict disciplinary action.

- 9. Students under the influence of any prohibited substances or in an intoxicated state may face strict disciplinary action.
- 10. Personnel from Delhi Police & Security Agency shall be available at Police post, Entry Gate, Control Room at Main Venue etc. In case of any emergency or distress the students/visitors may contact them.
- 11. CATS, Dwarka will station its 02 Ambulances inside the Campus for any untoward incident.
- 12. The Entry of Visitors/Students shall be video recorded for security reason. Further, the entire campus will also be under CCTV survilance.
