## **NOTICE INVITING e-TENDER**

1. The Director, Students' Welfare, on behalf of the GGSIPU invites online tenders in two bid system (Technical & Financial) from approved and eligible contractors as per eligibility criteria for the work of Hiring and Erection of Tentage, Light, CCTV, Sound and miscellaneous works for Annual Cultural festival "Anugoonj 2025" to be held during the period 24th to 26th February, 2025 at Dwarka Campus.
2. The work is estimated to cost Rs. 35,40,000/- (Rupee Thirty Five Lakh Forty Thousand Only) -Inclusive GST.
3. Tender documents consisting of conditions, the scope of works to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen and downloaded from website <http://govtprocurement.delhi.gov.in> in free of cost.
4. The intending bidder must read the terms and conditions carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
5. Information and Instructions for bidders posted on website shall form part of bid document.
6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
7. Contractor can upload documents in the form of PDF format.
8. Contractor must ensure to quote rate of each item. Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
9. **Evaluation and Award of Work:**

(9.1) **Preliminary Evaluation**

The purpose of this stage is only for preparing a list of all eligible bidders. Documents of only those bidders shall be scrutinized for initial eligibility whose Earnest Money deposit is found to be in order. Bids without earnest money deposit in requisite shape and amount shall be summarily rejected.

The initial eligibility (stage-I) shall be decided on the basis of evaluation of documentary evidence provided by the applicants in support of their eligibility according to the Initial Eligibility Criteria as listed below.

Individual agency that fulfils the following requirements shall be eligible to apply:-

- a) Individual agency should have satisfactorily completed during last seven years ending last day of receipt of bids:-
  - i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost or two similar works each costing not less than 60% of the estimated cost or one similar work costing not less than 80% of the estimated cost.

**AND**

- ii) One work of tentage and light / sound costing not less than the amount equal to 40% of the estimated cost of any cultural fest/ concert/ star night/ convocation or similar events with central / state government organization / central autonomous body / central public sector undertaking / Educational institution / government university/reputed institutions.

**Note:** Similar work shall mean providing tentage with truss / hanger structure and allied works including lighting or sound on hire for Central/State Govt. Department/PSU /College/Institute/University/reputed institutions. The value of similar work for eligibility as above should be for one location and for one such function. Similar work part of rate contract or multiple works will be evaluated as separate works for eligibility. The bidder to provide value of similar work forming part of rate contract completed duly certified by client. Performance certificate and work completion certificate of the works executed by the agency

to be submitted in Form 'B' signed by officer of rank Executive engineer or equivalent or higher. Agency to provide details of works in Form 'A'. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last day of submission of tenders.

- b) The agency should have valid GST registration. Copy of registration to be attached.
- c) The agency should attach copy of PAN card.
- d) The agency should have Average Annual Turnover of Rs.35,40,000/- (Rupee Thirty Five Lakh Forty Thousand Only) - for last 03 Financial Years ending 31.03.2024 duly certified by Chartered Accountant along with copies of Income Tax Return.

**(9.2) EVALUATION OF TECHNICAL BID (Stage-I):**

All applicants qualifying **Preliminary Evaluation** shall be evaluated for their technical capability according to the prescribed evaluation criteria listed below:

- 1) The eligible bidders will have to make presentation of their proposals for assessment by Board of Assessors. On the basis of the presentation, the bidders will be awarded marks out of 100 by Board of Assessors.
- 2) The date, time and venue of presentation shall be intimated separately. The maximum time allotted to each bidder for the presentation shall be 15 minutes.
- 3) The evaluation of the Technical Bid (Presentation) shall be on the basis of criteria given below:

- 4) The decision of the Board of Assessors shall be final and binding and no claim, whatsoever, shall be entertained.

**10. Financial bid:** The Bidder shall also submit this financial bid (through online mode only) quoting rate in the format along with the online submission of technical bid.

#### **11. Opening and Evaluation of Financial Bid**

- (i) The bidders who will score at least 60% combined marks in both Stages (Stage I + Stage II) shall only be considered as eligible for next stage of Opening of Financial Bid. The date of opening of financial bid will be notified separately.
- (ii) Financial Score: The lowest financial proposal (FM) will be given a financial score of 100 points. The Financial Score (FS) of the other proposal will be computed as follows:  
$$FS = 100 \times FM/F$$
  
(F = Cost/Amount of financial proposal under consideration)
- (iii) The final evaluation will be done according to the Combined Weighted Score using the weightage as given below:  
$$\text{Combined Weighted Score} = (0.20 \times \text{Marks achieved in Technical Bid Stage – I}) + (0.50 \times \text{Marks achieved in Technical Bid Stage –II}) + (0.30 \times \text{Financial Score})$$
- (iv) On the basis of the Combined Weighted Score as calculated above, the qualified Bidder shall be ranked. The proposal obtaining the highest Combined Weighted Score shall be ranked as H-1 followed by the proposals securing lesser marks as H-2, H-3 etc. The bidder ranked H-1 may be invited for negotiations, if required and shall be recommended for award of contract.
- (v) In case more than one bidder has same highest Combined Weighted Score in the overall evaluation, then the bidder scoring higher marks in Technical Bid Stage –

I & II combined together shall be recommended for award of work. In case, more than one bidder has same marks in Technical Bid Stage – I & II combined together, then the bidder scoring higher marks in Technical Bid Stage – II shall be recommended for award of work.

(vi) **Illustrative Example:**

- a) Suppose financial bid of 3 bidders, namely, A, B and C, are opened.
- b) The Financial Scores of A, B and C as explained in the para 11 (ii) above, work out to be 83, 100 and 91 respectively.
- c) The marks scored by A, B and C in Technical Bid Stage – I & II are (75 & 70), (80 & 85) and (70 & 90) respectively.
- d) The Combined Weighted Score of three bidders i.e. A, B and C according to the methodology given at para (iii) above will be as given below:

The above three proposals in the combined Technical and Financial Evaluation will be ranked as given below:

Bidder B, therefore, will be declared as the winner of the selection procedure and recommended for negotiation/approval to the Competent Authority.

- (vii) The University is not bound to accept any or all the proposals submitted and reserves the right to reject all the proposals without any liability to the bidder(s).

**12. Award of Contract**

- i) The selection of agency will be at the sole discretion of the University, which reserves the right to accept or reject any or all the proposals without assigning any reason. The University also reserves the right to call for additional information from the bidders as & when required at a later stage.
- ii) The contract shall be awarded to the highest scorer. The decision of the University shall be final and binding in this regard.

15. Last date for submission of tender document is 10.02.2025 .upto 15.00 Hrs and same shall be opened on same date at 15.30 hrs.
16. The site for the work is available.
17. Tender documents consisting of plans, specifications, the scope of works of items to be executed and the set of terms and conditions of contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website <http://govtprocurement.delhi.gov.in> free of cost.
18. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
19. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.

20. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
21. Earnest money deposit amounting to **Rs. 70,800/- (Rupees Seventy Thousand Eight Hundred only)** in the form of Demand Draft or Pay order or fixed deposit receipt (drawn in favour of Registrar GGSIPU, New Delhi) **or Online payment** shall be scanned and uploaded to the e-tendering website within the period of tender submission and original should be deposited in office of Director, Students' Welfare, Shopping Complex at GGSIPU Sec 16C Dwarka Campus New Delhi-110078 in separate envelope marked 'EMD' by last date and time of submission. In case of online submission of amount against EMD, no physical EMD is to be deposited. Bidder will upload the copy of online receipt clearly indicating UTR No. of the online transaction for EMD.

EMD of unsuccessful bidder shall be returned after award of work and EMD of successful bidder shall be returned after completion of work. No interest will be paid on EMD submitted in Online and Offline mode.

Copy of PAN card, GST registration, Copy of experience of similar work etc. shall be scanned and upload to the e-tendering website within the period of tender submission and only the successful bidder has to submit the certified copies 03 days after opening of Financial Bid in a separate envelop marked as "Other Documents".

Only the EMD to be deposited in original by all bidders with due mention of Name of work, date & time of opening of tenders and to be submitted in the office of Director, Students' Welfare, Shopping Complex, GGSIPU, New Delhi by 10.02.2025 at 3.00 PM.

Online tender documents submitted by intending bidders shall be opened only of those bidders, whose Earnest Money Deposit obtained from the Bidders.

Those bidder which are registered with MSME /MSE for the items mentioned in the tender document, are exempted for submission of EMD only and are required to submit a copy of valid registration certificate in place of EMD as per GFR 170(i) and also upload Form of Bid Security Declaration in lieu of EMD (Form D)

The bid submitted shall be opened online at 03.30 P.M. on 10.02.2025.

22. The bid submitted shall become invalid if:
  - i. The bidder is found ineligible.
  - ii. The bidder does not upload all the documents as stipulated in the bid document.
  - iii. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically in the office of tender opening authority
23. All work shall be **completed one day before dates notified for the function upto 12:00 Noon**. The bidder will have to submit the details of works carried out for each location vis a vis scope of work mentioned in para 5 of Conditions of Contract.
24. The Contractor whose tender is accepted will be required to furnish performance guarantee **at 5% of the tendered amount within the 03 Days of the issue of letter of acceptance of bid**. This guarantee shall be in the form of Banker's Cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank or Fixed Deposit Receipts of any Schedule Bank or in the form of an irrevocable bank guarantee bond of any scheduled nationalized bank in accordance with the form prescribed. Performance guarantee shall be returned after successful completion of work. No interest shall be paid on Performance Guarantee. Payment Link -

25. Copies of documents pertaining to the works will be open for inspection by the tenderers at the office of Director (Students' Welfare). Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves the form and nature of the site, the means of access to the site, the accommodation they may require and before submitting their tenders and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract document. Submission of a tender by tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.
26. The competent authority on behalf of the GGSIPU does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
27. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
28. The Competent Authority on behalf of GGSIPU reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
29. The Contractor shall not be permitted to tender for works in the Office of Director(Student Welfare) responsible for award and execution of, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any officer in the GGSIPU. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
30. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the GGSIPU, then the GGSIPU shall, without prejudice to any other right or remedy, be at liberty to forfeit entire earnest money as aforesaid. Further, the tenderer shall not be allowed to participate in the re tendering process of the work.

## INFORMATION AND INSTRUCTIONS FOR CONTRACTORS FOR e-TENDERING FORMING PART OF NIT AND TO BE POSTED ON WEBSITE

1. Information and instructions for Contractors will form part of NIT.
2. The Bid Document as uploaded can be viewed and downloaded free of cost by anyone including intending bidder. But the bid can only be submitted after uploading the mandatory scanned documents.
3. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
4. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
5. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
6. On opening date, the contractor can login and see the bid opening process.
7. Contractor can upload documents in the form of **JPG** format or **PDF** format.
8. It is mandatory to upload scanned copies of all the documents as stipulated in the bid document. If such document is not uploaded, the bid will become invalid and shall be rejected.
9. If the contractor is found ineligible after opening of bids, his bid shall become invalid and shall be rejected.
10. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the contractor the bid shall become invalid and shall be rejected.
11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "**0**" (**ZERO**).
12. **Payment of cost of Tender documents:-**The collection of cost of Tender documents is dispensed away with, as there is no physical supply of tender documents and also to have absolute anonymity of the bidders participating in e-procurement solution. The bidders can view/download the tender documents, from the <http://govtprocurement.delhi.gov.in>.
13. **Submission of bids:** The bidders who are desirous of participating in 'e' procurement shall submit their price bids in the standard formats prescribed in the Tender documents, displayed at <http://govtprocurement.delhi.gov.in>. The bidder should upload the scanned copies of all the relevant certificates, documents etc., on the <http://govtprocurement.delhi.gov.in> in support of their price bids. The bidder shall sign on all the statements, documents, certificates uploaded by him, owning responsibility for their correctness/authenticity.

14. **Payment of Bid Security (Earnest Money Deposit):** The EMD shall be in the form of Pay Order/FDR of a scheduled bank issued in favour of Registrar, GGSIPU, New Delhi have to be deposited. Alternatively EMD can also be deposited Online

Zerex copy of the DD/Pay Order/FDR is to be scanned and uploaded alongwith the Bid, and the original Pay Order/FDR shall be sent to the office of Director, Students' Welfare so as to reach before the date and time mentioned in NIT. In case of online submission of amount against EMD, no physical EMD is to be deposited. Bidder will upload the copy of online receipt clearly indicating UTR No. of the online transaction for EMD. Failure to furnish the original DD/Pay Order/FDR as EMD before the date and time mentioned in NIT will entail rejection of bids.

Those bidder which are registered with MSME /MSE for the items mentioned in the tender document, are exempted for submission of EMD only and are required to submit a copy of valid registration certificate in place of EMD as per GFR 170(i) and also upload Form of Bid Security Declaration in lieu of EMD (Form D)

15. **Price Bid Opening:-** The Price Bids will be opened online by the Director, Students' Welfare at the specified date & time and the result will be displayed on the <http://govtprocurement.delhi.gov.in> which can be seen by all the bidders who participated in the tenders.
16. **Processing of Tenders:** The concerned officer/officers will evaluate and process the tenders as done in the conventional tenders and will communicate the decision to the bidder online.
17. **Participation of Bidders at the time of opening of bids:** Bidders have two options to participate in tendering process at the time of opening of Bids:
- i) Bidders can come to the place of opening of bids (electronically) as done in the conventional tender process.
  - ii) Bidders can see the process online.

### Preamble

WHEREAS the Principal/Owner has floated the Tender (herein after referred to as "Tender/Bid") and intends to award, under laid down organizational procedure, contract for –  
Name of work: Hiring and Erection of Tentage, Light, CCTV, Sound and miscellaneous works for Annual Cultural festival "Anugoonj 2025" at Dwarka Campus hereinafter referred to as the "Contract".

And WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement(hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants in this pact, the parties hereby agree as follows and this pact witnesses as under:

### Article 1: Commitment of the Principal/Owner

- 1) The Principle/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
  - c) The Principal/Owner shall endeavour to exclude from the Tender process any person, whose conduct in the past has been of biased nature.

- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

**Article 2: Commitment of the Bidder(s)/Contractor(s)**

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government/Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The binder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
  - a) The bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
  - b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contractor(s) will; not use improperly;, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
  - e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.

- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willfull misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of other and/or to influence the procurement process to the detriment of the Government interests.
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/her reputation or property to influence their participation in the tendering process).

### **Article 3: Consequences of Breach**

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach or this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2) Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1) the principal/owner apart from exercising any legal right that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

### **Article 4: Previous Transgression**

- 1) The bidder declares that no previous transgressions occurred in the last 5 year with any other Company in any country confirming to the anticorruption approach or with



Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.

- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/holiday listing of the Bidder/Contractor as deemed fit by the Principal/Owner.
- 3) If the Bidder/Contractor can prove that he has resorted/recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

#### **Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors**

- 1) The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation (s) of the principles laid down in this agreement/Pact by any of its Sub-contractor/Sub-vendors.
- 2) The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
- 3) The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

#### **Article 6: Duration of the Pact**

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 12 months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded. If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/determined by the Competent Authority, GGSIPU.

#### **Article 7: Other Provisions**

- 1) This pact is subject to Indian Law, place of performance and jurisdiction is the Head quarters of the Division of the Principal/Owner, who has floated the Tender.
- 2) Changes and supplements need to be made in writing. Side agreements have not been made.
- 3) If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4) Should one or several provisions of this pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 5) It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement/Pact or any action taken by the Owner/Principal in accordance with this Integrity agreement /pact interpretation thereof shall not be subject to arbitration.

**Article 8: Legal and Prior Rights**

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contract documents with regard any of the provisions covered under this Integrity Pact.

## GENERAL RULES AND DIRECTIONS

1. Notice Inviting Tender will state the work to be carried out, as well as the date for submission and opening of tenders and the time allowed for carrying out the work, also the amount of earnest money to be deposited at the time of purchase of tender, the performance Guarantee to be deposited by the successful tenderer. Copies of the conditions, and any other documents required in connection with the work signed for the purpose of identification by the officer inviting tender shall also be open for inspection by the contractor at the office of officer inviting tender during office hours.
2. In the event of the tender being submitted by a firm, it must be signed separately by each partner thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so, such power of attorney to be produced with the tender, and it must disclose that the firm is duly registered under the Indian Partnership Act, 1952.
3. Receipts for payment made on account of work, when executed by a firm, must also be signed by all the partners, except where contractors are described in their tender as a firm, in which case the receipts must be signed in the name of the firm by one of the partners, or by some other person having due authority to give effectual receipts for the firm.
4. Any person who submits a tender shall fill up the financial bid, stating at what rate he is willing to undertake the work. Tenders, which propose any alteration in the work specified in the said form of invitation to tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort, including conditional rebates, will be summarily rejected. No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tenders for each. Tender shall have the name and number of the works to which they refer, written on the envelopes.
5. The officer inviting tender or his duly authorized representative, will open tenders in the presence of any intending contractors who may be present at the time. In the event of a tender being rejected, the earnest money of unaccepted tenders shall thereupon be returned to the contractor, without any interest.
6. The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.
7. Use of correction fluid, anywhere in tender document is not permitted. Such tender is liable for rejection.
8. Only rates quoted shall be considered. Any tender containing percentage below/above the rates quoted is liable to be rejected. Rates quoted by the contractor in figures and words shall be accurately filled in so that there is no discrepancy in the rates written in figures and words. However, if a discrepancy is found, the rates which correspond with the amount worked out by the contractor shall unless otherwise proved be taken as correct. If the contractor does not work out the amount or it does not correspond with the rates written either in figures or in words, then the rates quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and in words tally but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount.

9. All rates shall be quoted on the financial bid. Special care should be taken to write the rates in figures as well as in words and the amount in figures only, in such a way that interpolation is not possible. The total amount should be written both in figures and in words. In case of figures, the word 'Rs.' should be written before the figure of rupees and word 'P' after the decimal figures, e.g. 'Rs.2.15 P' and in case of words, the word, 'Rupees' should precede and the word 'Paise' should be written at the end. Unless the rate is in whole rupees and followed by the word 'only' it should invariably be upto two decimal places. While quoting the rate in schedule of quantities, the word 'only' should be written closely following the amount and it should not be written in the next line.
10. The Contractor whose tender is accepted will be required to furnish performance guarantee **at 5% of the tendered amount within the 03 Days of the issue of letter of acceptance of bid.** This guarantee shall be in the form of Banker's Cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank or Fixed Deposit Receipts of any Schedule Bank or in the form of an irrevocable bank guarantee bond of any scheduled nationalized bank in accordance with the form prescribed. Performance guarantee shall be returned after successful completion of work. No interest shall be paid on Performance Guarantee. 11. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Officer-in-Charge shall be communicated in writing to the office of Director, Students' Welfare.
12. GST, purchase tax, turnover tax or any other tax in respect of this contract shall be payable by the Contractor and GGSIPU will not entertain any claim whatsoever in respect of the same.
13. The contractor shall give a list of both gazetted and non-gazetted GGSIPU employees related to him.
14. The tender for the work shall not be witnessed by a contractor or contractors who himself/themselves has/have tendered or who may and has/have tendered for the same work. Failure to observe this condition would render, tenders of the contractors tendering, as well as witnessing the tender, liable to summary rejection.

## CONDITIONS OF CONTRACT

1. The Contract means the documents forming the tender and acceptance thereof, together with the documents referred to therein including these conditions and instructions issued from time to time by the Officer-in-Charge and all these documents taken together, shall be deemed to form one contract and shall be complementary to one another.
2. In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them:
  - i) The expression works or work shall, unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional.
  - ii) The Site shall mean the land/ or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work, is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract.
  - iii) The Agency / Contractor / Tenderer shall mean the individual, firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative of such individual or the persons composing such firm or company, or the successors of such firm or company and the permitted assigns of such individual, firm or company.
  - iv) The GGSIPU means the Guru Gobind Singh Indraprastha University and his successors.
  - v) The Officer-in-Charge means the Director(Student welfare) or his authorised representative
  - vi) Excepted Risk are risks due to riots (other than those on account of contractor's employees), war (whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion revolution, insurrection, military or usurped power, any acts of Government, damages from aircraft, acts of God, such as earthquake, lightening and unprecedented floods, and other causes over which the contractor has no control and accepted as such by the Accepting Authority or causes solely due to use or occupation by Government of the part of the works in respect of which a certificate of completion has been issued or a cause solely due to Government's faulty design of works.
  - vii) Department means Guru Gobind Singh Indraprastha University.
  - viii) Tendered value means the value of the entire work as stipulated in the letter of award.
3. Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.

4. Headings and Marginal notes to these General Conditions of Contract shall not be deemed to form part thereof or be taken into consideration in the interpretation or construction thereof or of the contract.
5. The work to be carried out under the Contract shall, except as otherwise provided in the conditions, include all labour, materials, tools, plants, equipment, transport, insurance etc which may be required in preparation of and for and in the full and entire execution and completion of the works. The descriptions of work given below shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion of the work as aforesaid in accordance with good practice and recognized principles.

- 13 It is also a term of the contract that if any fee payable to the arbitrator, shall be paid equally by both the parties. It is also a term of the contract that the arbitrator shall be deemed to have entered in the reference on the date he/she issues notice to both the parties calling them to submit their statement of claims and counter statement of claims.
- 14 Force Majeure. For purpose of this clause, 'Force Majeure' means an event beyond the control of the contractor and not involving the contractor's fault or negligence and not fore see able. Such events may include, but are not limited to, acts of the University either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargo. If a Force Majeure situation arises, the contractor shall promptly notify the University in writing of such conditions and cause thereof. Un less otherwise directed by the University in writing, the contractor shall continue to perform its obligations under this contract as far as reasonably practical and shall seek all reasonable alternative means for performance not prevented by Force Majeure event.
