**To apprise the matter of shifting of Amity Law School from Amity University Campus, Noida to some other place in Delhi or NCR**

The Board of Affiliation after going through the Agenda has observed that Amity Law School has been continuing in its temporary campus located in sector -125, Noida since the year 2007 and has been issued NOC by the concerned State Govt. i.e. U.P. Govt., the Statutory Body i.e. BCI and Directorate of Higher Education, Govt. of NCT Delhi also has issued no objection in accepting the NOC given by the U.P. Govt.

The Board further noted that the institute failed to comply with the earlier decision of the Board taken in its 62<sup>nd</sup> meeting that *"Amity Law School shall shift its campus from existing temporary campus at Amity University, Noida, to some other place in Delhi or NCR Region as per jurisdiction of the GGSIPU for running the BA LLB Programme under the aegis of GGSIP University, on or before 31<sup>st</sup> December 2014 and accordingly will submit NOC from the concerned State Government as per the rules and regulations of the University."*

The Board after deliberations and keeping in view the NOC from UP Government till 2020-21; approval of BCI till 2017-18 and No Objection of Directorate of Higher Education, vide its letter No. DHE-4(29)/NOC/ALS/13-14/2613-14 dated 16.06.2017 for accepting the NOC given by the UP Govt. resolved that Amity Law School may be allowed to take part in Counselling and be allowed to continue from its Noida campus for Academic Session 2017-18.
