No.F.1(44)/Amd/Stat/IPU/ADRP/2008/8384 ÷ In pursuance of the provisions of Sub-Section (2) of Section 26 of the Guru Gobind Singh Indraprastha University Act, 1998 (9 of 1998), the Board of Management of Guru Gobind Singh Indraprastha University, with the prior approval of Chancellor, hereby makes the following amendments in Statute 3 of First Statutes for appointment of Vice-Chancellor of the University:-

(1)	The Vice Chancellor shall be a whole time salaried officer of the University.	(1) No change.
(2)	The Vice Chancellor shall be appointed by the Chancellor from a panel of three names (written in the alphabetical order) recommended by the selection committee constituted under clause (3).	(2) The Vice Chancellor shall be appointed by the Chancellor from a panel of three names (written in the alphabetical order) recommended by the search cum selection committee constituted under clause (3).
(3)	The selection committee referred to in clause (2) shall be headed by the Chief Justice of the Delhi High Court and shall consist of- (a) the Secretary to the Government of India in the Department of Science and Technology; and (b) the Chief Secretary to the Government who shall be the member-secretary of the selection committee.	(3) The search cum selection committee referred to in clause (2) shall be headed by an eminent academician and shall consist of- (a) Former or present Director of any Indian Institute of Technology; (b) Former or present Director of any Indian Institute of Management; (c) Former or present Director of any National Law School; (d) Secretary(Higher Education) of Govt. of NCT of Delhi as member-secretary.
(4)	For suggesting names of persons for consideration of the selection committee, there shall be constituted a search committee consisting of the following:- (a) The Vice Chancellor of an Indian University; (b) The Director, All India Institute of Medical Sciences,	(4) Deleted

(5)	<p>The search committee shall forward the names (in the alphabetical order) to the member-secretary of the selection committee:</p> <p>Provided that the selection committee may also consider names not suggested by the search committee.</p>	(5) Deleted
