The Vice Chancellor in his opening remarks shared with all the members that University was inspected by the NAAC Peer Team as a part of the 3rd cycle of NAAC Accreditation of the University during 7-9th February 2023. The University put up a good show and after this the University received its final grade from NAAC on 14th February 2023. University has been granted highest A++ Grade by NAAC. He further added that due to the consistent good

performance of the University, the Accreditation has been granted for a period of 7 years instead of the normal 5 years. This shall be valid till 13.2.2030.

He appreciated the efforts made by NAAC Core Committee for the tremendous efforts put day-in and day-out by them in the last few months leading to the achievement of highest grade. He also applauded the support and cooperation extended by the whole IQAC for the various initiatives taken in the last 2 years.

All the members especially Maj. Gen. N.K. Dhir (Retd.) , Dr Jatinder Singh, Ms Sarika Gulyani congratulated on this wonderful achievement.
