The course curriculum consists of eight (08) semesters which is optimal blend of theory and practice.

Admission Criteria

Mode of Selection: Central University Entrance Test (CUET) National Test Qualified. CUET registration process is ongoing (<https://cuet.samarth.ac.in>)

Mandatory Requirement: Registration in GGSIP University Admission Portal is compulsory (<https://ipu.admissions.nic.in/>).

Last date: 15.05.2024 (Counselling date is expected in the 2nd week of June 2024. Refer: Admission brochure page no. 106.)

Eligibility Criteria: 10+2 in Science Stream with minimum 50% marks and 45% marks for SC/ST candidates
