GUIDELINES FOR SUBMISSION

1. Indraprastha Journal of Management (IJM) invites original papers, articles and cases on various aspects of management research and practice. IJM is a peer-reviewed journal. Articles submitted to the journal are initially screened by the editor and those that are considered appropriate are forwarded for a formal review. Based on the referees' comments, authors may be requested to make necessary revisions and resubmit the manuscript. The following guidelines must be strictly followed while sending contributions.
2. Manuscripts must be submitted in duplicate. Contributions should not ordinarily exceed 6,000 words and should be typed on A4 paper in Times New Roman, font size 12, double-spaced with a margin of 1 inch all around. The cover page should bear only the title of the paper, author/s' names, designations, official addresses, phone/fax numbers, and e-mail ids. The author/s' name/s should not appear anywhere else in the manuscript. The first page should also give the title of the manuscript. Book reviews should not exceed 800 words.
3. All manuscripts and editorial correspondence should be addressed to The Editor, Indraprastha Journal of Management, University School of Management Studies, Guru Gobind Singh Indraprastha University, Kashmere Gate, Delhi 110403. A copy of the manuscript should be sent by E-mail to: editor_ijm@hotmail.com. The hard copy of the manuscript and the electronic copy must match exactly.
4. The manuscript should include an abstract of about 150 words.
5. Tables, figures and graphs should be given at appropriate places and should be neatly drawn and labelled.
6. All notes should be indicated by serial number in the text, and literature cited should be detailed under notes at the end of the paper bearing corresponding numbers, before the references.
7. Care should be taken to ensure that references are complete in all respects and are arranged in alphabetical order. Journal references should be presented as:

Mascarenhas, Oswald A. J. and Mary A. Higby (1993), "Peer, Parent, and Media Influences in Teen Apparel Shopping," *Journal of the Academy of Marketing Science*, 21 (No. 1, Winter), 53-58.

In case of more than one publication by the same author, list them in chronological order, with the older item appearing first. For more than one publication in one year by the same author, use small (lower case) letters to distinguish them (e.g. 2005a, 2005b). For example:

Foxman, Ellen R., Patriya S. Tansuhaj, and Karin M. Ekstrom (1989a), "Family Members' Perceptions of Adolescents' Influence in Family Decision Making," *Journal of Consumer Research*, 15 (March), 482-491.

Foxman, Ellen R., Patriya S. Tansuhaj, and Karin M. Ekstrom (1989b), "Adolescents' Influence in Family Purchase Decisions: A Socialization Perspective," *Journal of Business Research*, 18, 159-172.
